Imputed income for taxes attributable to your OQA and/or their children's coverage will be reported on one line item described as Dependent Personal Insurance (DPI) under the Hours and Earnings box on your biweekly or monthly pay stub. This amount represents the cost of providing benefits for your OQA and/or their children as well as any employee pre-tax deductions attributable to OQA coverage that must be converted to an after-tax deduction. The effect of reporting this amount as DPI will "gross-up" your actual gross earnings so that required taxes on the imputed income will be deducted from your pay.

The Imputed Income Tax Table reflects the additional amount that will be added to your gross income strictly for taxation purposes.
