Magellan Rx Management is pleased to administer your University of Michigan (U-M) Prescription Drug Plan. We are writing to inform you of a benefit available through the University of Michigan's MHealthy Tobacco Consultation Service (TCS), which provides support and resources for U-M drug plan members.

Prescription only and generic over the counter (OTC) smoking cessation medications are covered at zero (\$0) co-pay for U-M drug plan members. This coverage complies with the preventive care services provisions required under the Affordable Care Act. To receive the zero (\$0) co-pay benefit, members need a doctor's prescription or an authorization letter from TCS prescribing the smoking cessation medication.

Our records indicate that you recently filled a prescription for a tobacco treatment medication and may be interested in participating in this program. Below are both the covered generic OTC and prescription medications and their monthly co-pay amounts.

Medication	How Obtained	Co-Pay/Month
Generic Nicotine Patch (OTC)	Requires prescription or TCS authorization letter	\$0
Generic Nicotine Gum (OTC)	Requires prescription or TCS authorization letter	\$0
Generic Nicotine Lozenge (OTC)	Requires prescription or TCS authorization letter	\$0
Nicotine Inhaler	Prescription	\$0
Nicotine Spray	Prescription	\$0
Bupropion (generic for Zyban)	Prescription	\$0
Chantix® (varenicline)	Prescription	\$0

Note: Generic OTC coverage is limited up to a 180-day supply every 12 months.

Research shows that behavioral support may be beneficial to your efforts to quit smoking. Even if your doctor prescribes a smoking cessation medication, you may still enroll in MHealthy's TCS behavioral support program by calling 734-998-6222. TCS specialists can provide an authorization letter for covered OTC items. Learn more at mhealthy.umich.edu/tobacco.

The TCS letter for OTC medications is accepted at participating pharmacies. For ease of processing, we suggest you use one of the pharmacies listed below, who are familiar with this program. NoviXus mail order cannot dispense OTC items.
